

## LIST OF DEFINITIONS

### **Affirmable Professional Service Provider (APSP)**

A partnership, sole trader or legal entity which provides professional services, adheres to statutory labour practices, is registered with South African Revenue Services and is a continuing and Independent Enterprise for profit, providing a Commercially Useful Function and:

- a) which is at least two thirds owned by one or more Previously Disadvantaged Individuals; and
- b) whose management and daily business operations are under the Control of and are performed by one or more of the Previously Disadvantaged Individuals who effectively Own and Control it.

### **Gross Fixed Capital Formation (GFCF)**

The Gross Fixed Capital Formation (GFCF) is the total value of a producer's acquisitions, less disposals of fixed assets, plus certain additions to the value on non-produced assets. The GFCF is a country's purchasing parity adjusted rough investment in construction and in machinery and equipment that is given in World Bank and OECD macroeconomic data.

### **Gross National Product (GNP)**

The market value of all goods and services produced in a country during a given year. The GNP is the most comprehensive measure of a nation's total output of goods and services. It is the sum of the monetary values of consumption, investment, government purchases of goods and services, and net exports.

### **Historically Disadvantaged Individual (HDI)**

(Refer to Preferential procurement regulations, as approved April 2001 pertaining to Preferential Procurement Policy Framework Act: no. 5 of 2000)

HDI means a South African citizen-

- 1) who had no franchise in national elections prior to the introduction of

the Constitution of the Republic of South Africa, 1983 (Act No 110 of 1983) or the Constitution of the Republic of South Africa, 1993 (Act No 200 of 1993) (“ the Interim Constitution”); or

- 2) who is a female; or
- 3) who has a disability:

Provided that a person, who obtained South African citizenship on or after the coming to effect of the Interim Constitution, is deemed **not** to be an HDI;

#### **Mandated principal**

Mandated principals are senior directors, Partners, Sole proprietors or Members of consulting engineering firms who have been designated as such by their firms in order to serve as the single representative of their firm regarding SAACE matters or the single point of contact for correspondence and other contact with the SAACE.

#### **Previously Disadvantaged Individual (PDI)**

Individual who, being a South African citizen, falls into a population group that had no franchise in national elections prior to the introduction of the 1984 constitution and the tricameral parliamentary system, subject to persons who obtained South African citizenship after 2 February 1990 demonstrating traceable South African lineage. It is incumbent on individuals to demonstrate their claims to fall into such population groups on the basis of identification and association with and recognition by the members of such groups.

#### **Priority Population Group (PPG)**

Previously Disadvantaged Individuals who fall into population groups that were not offered a franchise in national elections before or after the introduction of the 1984 tricameral parliamentary system and only received the franchise during 1994.
